Procedural Fees	<ul style="list-style-type: none"> Procedural fees apply for all patients having surgical or treatment room procedures. The fee will depend on the complexity of your procedure. Procedural fee is discounted for pension card and health care card holders and children under 16. I will advise you of the procedure fee at the time of planning your procedure.

Payment must be made at the time of the consultation by cash, EFTPOS or credit card. QMSC uses the Easyclaim service, and your Medicare rebate will return, almost immediately, after swiping your EFTPOS card. Ensure your details are registered with Medicare.
