Payment must be made at the time of the consultation by cash, EFTPOS or credit card. QMSC uses the Easyclaim service, and your Medicare rebate will return to your account, almost immediately, after swiping your EFTPOS card. Ensure your details are registered with Medicare. If you have not previously provided Medicare with your bank account details, please, [click here to register with Medicare online](#). You will be asked to pay any outstanding accounts before any future appointments can be made.

Ensuring appropriate appointment types are used, is one way to reduce the cost of healthcare. This is a collaborative arrangement and I appreciate your assistance in choosing the right appointment type for your needs.

If you have a chronic health condition/s consider using 3 monthly chronic disease management review appointments, health assessments and home medication reviews. I have committed to bulk bill these appointments (accepting your Medicare rebate only as payment) for management of your chronic condition/s and find these a valuable resource to improve your care. When on a chronic disease management plan, you are still able to book regular appointments whenever required for other concerns.
